Vendor agrees that it will protect, defend, hold harmless and indemnify the The Town of Kearny, their directors, officers, agents, employees, and volunteers from and against any and all expenses, claims, actions, liabilities, attorney fees, damages and losses of any kind whatsoever, actual or alleged, resulting from or concerned with the participation as a vendor in the event. The Town of Kearny should not be liable for any loss or damage to any merchandise or personal property in or about vendor's booths regardless of the cause of such loss or damage.
